You have asked about the USG's options regarding the 10 Amcits from Idaho in Haiti, from the New Life Children's Refuge, who are currently being charged with child abduction and criminal association crimes under Haitian law. “ The 10 Americans have been imprisoned since Jan. 29 in the back of the same police station used by President René Préval as the seat of Haiti's government since the earthquake. They had been told by their lawyers that at least some of them would be on their way home on Thursday. But the judge overseeing their case, Bernard Saint-Vil, recommended to the prosecutor that they be tentatively released from custody and permitted to leave the country as long as a representative stayed behind until the case was completed.

Mr. Puello has been acting as a spokesman and legal adviser in the Dominican Republic for some of the detainees.

The head of the Salvadoran border police, Commissioner Jorge Callejas, said in a telephone interview that he was investigating accusations that a man with a Dominican passport that identified him as Jorge Anibal Torres Puello led a human trafficking ring that recruited Dominican women and under-age Nicaraguan girls by offering them jobs and then putting them to work as prostitutes in El Salvador.

SANTO DOMINGO, March 19 (Reuters) - A Dominican Republic man who acted as legal adviser to a group of U.S. missionaries held for several weeks in Haiti on child kidnapping charges has been arrested in Santo Domingo, local police said on Friday.

**Jorge Puello Torres**, wanted by El Salvador as a suspect in a human trafficking ring, was detained at a car wash in the city late on Thursday,

Suspensions about Silsby's intent to smuggle or traffic the children to the Dominican Republic further increased, when on March 19, 2010, Silsby's legal advisor—Jorge Torres-Puello, an American-Dominican living in the Dominican Republic as a fugitive—was arrested and accused of human trafficking.<sup>70</sup> U.S. authorities revealed that Torres-Puello was “linked to a network that trafficked in Haitian and Central American children and [was] wanted in the United States, El Salvador and Costa Rica.”<sup>71</sup> His wife was

In early 2010, Torres surfaced in the Dominican Republic posing as a lawyer representing American church workers detained in Haiti in the wake of the earthquake in that country. Torres convinced a church that he was Jorge Torres Puello, an international lawyer and president of "Puello Consulting" in the Dominican Republic.
